## **ORDINANCE NO. 1213**

AN ORDINANCE TO CHANGE THE ZONING CLASSIFICATION FROM AGRICULTURE RESIDENTIAL TO R50 TWO-FAMILY RESIDENTIAL ON PROPERTY LEGALLY DESCRIBED AS TAX LOT 37A1A1A, IN THE SOUTHEAST QUARTER OF SECTION 24, TOWNSHIP 13 NORTH, RANGE 11 EAST OF THE  $6^{\text{TH}}$  P.M., SARPY COUNTY, NEBRASKA, CONSISTING OF APPROXIMATELY 38.46 ACRES, AND GENERALLY LOCATED AT THE NORTHWEST CORNER OF 132ND & PFLUG ROAD, SPRINGFIELD, NEBRASKA 68059; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA:

Section 1. Application. An application was filed by McCune Development, applicant, and Madam Land Company, owner, requesting a change of zoning classification from Agriculture Residential to R50 Two-Family Residential on Tax Lot 37A1A1A, in the Southeast Quarter of Section 24, Township 13 North, Range 11 East of the 6<sup>th</sup> P.M., Sarpy County, Nebraska, consisting of approximately 38.46 acres; and generally located at the northwest corner 132<sup>nd</sup> & Pflug Road, Springfield, Nebraska 68059.

Section 2. Approval to change the zoning classification from Agriculture Residential to R50 Two-Family Residential on Tax Lot 37A1A1A, in the Southeast Quarter of Section 24, Township 13 North, Range 11 East of the 6<sup>th</sup> P.M., Sarpy County, Nebraska. On September 9, 2025, the Springfield Planning Commission conducted a public hearing on the matter of changing the zoning classification from Agriculture Residential to R-50 Two-Family Residential and reported to the City Council that it recommended approval of the rezone. On October 21, 2025, the City Council opened a public hearing on said proposed changes and found and determined that the zoning classification from Agriculture Residential to R50 Two-Family Residential was advisable and in compliance with the Springfield Comprehensive Plan. The City Council hereby approved said proposed change in zoning classification from Agriculture Residential to R50 Two-Family Residential on Tax Lot 37A1A1A, in the Southeast Quarter of Section 24, Township 13 North, Range 11 East of the 6<sup>th</sup> P.M., Sarpy County, Nebraska, contingent upon the final plat for this property being recorded with the Sarpy County Register of Deeds.

<u>Section 3.</u> Effective Date. This Ordinance shall be in full force and effect from and after passage, approval and publication as provided by law.
