MINUTES

A regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. at City Hall on Tuesday, February 16, 2021. Present were Mayor Bob Roseland; Council Members: Roy Swenson, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

Consent Agenda

Regular Agenda

Agenda Item 1. Motion by Swenson, seconded by Craney, to waive the Community Building rental fee for SYAA 12U Baseball Team practices with the understanding that any paid renter with at least two weeks booking notice shall supersede the SYAA's use of the building every Sunday afternoon from 2:00-3:30 p.m. beginning February 28 and continuing through March for baseball practice. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 2. Gene Graves, developer of Springfield Pines Phase 1, reviewed his plan to develop Phase 2. He provided Council with a draft layout showing multi-family to the northwest and singlefamily residential to the east. Graves indicated that the west half would be completed first. Grading could begin this summer with lots being sold next year. Since the city's sewer system is at capacity and the South Sarpy Wastewater Agency will not be online until 2024, Graves is requesting the city allow him to construct a temporary sewer solution. Josh Seal, developer engineer with Foley Engineer, 3803 N. 153rd Street, Omaha, Nebraska, 68116, reviewed the mechanics of the temporary sewer solution. Sewage storage tanks would be located underground and then discharged appropriately. Seal noted that his team visited with NDEE about required limits and other regulations. Graves reported that ideally the temporary sewer would discharge into the city's storm water system on the northeast side of town near the Pit Stop. Alternatively, they could run an outfall source north and discharge further upstream. Graves pointed to examples of temporary and package plants being used throughout the Midwest, including local systems at Nebraska Crossing, Hawaiian Village and Beaver Lake. Council expressed their intent that Graves would be required to hook up to the new Sewer Agency system once it was made available. Said arrangement could be outlined in the subdivision agreement. Swenson asked how the temporary sewer solution would be operated. Graves noted that he would contract with People's Services for maintenance. Graves also reported that he has a 400 acre site at 72 nd and Capehart Road, within the Springfield Platteview School District, that Papillion is allowing them to use a temporary sewer solution. He shared an email from Adam Flanagan, Vice-President of Kuehl Capital, outlining the financial impact the subdivision would have on the city and the difference in waiting three years to develop. Council requested additional time to research and investigate this proposed sewer alternative.

Agenda Item 3. Members of the Sarpy County Agricultural Society including President Jim Jansen, Vice-President Dwayne Lange, Secretary Mike Rudolph, and Treasurer Chad Heinert were present to dispute the February 15 water billing read of 186,000 gallons of water and subsequent charge to their account. Swenson explained that if the meter malfunctions it will under report usage. He also gave examples of other disputes the city has received over the years in which the property owner swears they don't have a leak or problem and then find out they indeed do have a leak causing the high usage. Herzog asked if they checked their toilets and all internal and external pipes. Rick Lee, Water Operator, informed the Council that he spoke with the SYAA wrestling coach about this issue and he said the urinals keep running. Lee further stated he has no explanation for the high read and has since re-read the meter five times since February 1. Swenson shared pictures of an outside faucet on the 4-H building with a broken valve. He noted that a hose could easily be hooked up by someone. Lange thought the faucet was shut off in the utility room, but will check the line to be sure. He can't say that someone didn't turn it on.

Herzog asked if they had brought in a plumber to investigate. Lee noted that there has to be a leak somewhere. No further discussion.

Agenda Item 7. Pat Sullivan, Sarpy County Agricultural Society Attorney with Adams & Sullivan, 1246 Golden Gate Drive, Papillion, Nebraska, spoke on behalf of the Ag Society.
