**Agenda Item 1.** Council reviewed the Sarpy County Sheriff's monthly service report. Motion by Herzog, seconded by Neitzel, to move agenda item 1, regarding the Sarpy County Sheriff's monthly service report, to later in the meeting to allow time for a Sheriff's Department representative to arrive. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried. No representative attended.

**Agenda Item 2.** Mike Rooks, Executive Director of Grow Sarpy, reviewed the 2nd Quarter Report. Rooks introduced new hire with Grow Sarpy, Laura Harrison, Grow Sarpy Business and Community Relations Manager, who will be doing building retention and expansion to try to get people down in Sarpy to work and stay in Sarpy County. Rooks reported that Sarpy is still in need of more workforce housing and multi-family housing. Rooks also reported that Grow Sarpy recently distributed 1,230 construction kits to high school shop students including students at Platteview High School.

Agenda Item 3. Laura Osborn and Keith Hentzen with the Springfield Community Foundation discussed a grant opportunity through Meta for the construction of an e-bike station at the trailhead in Springfield Creek Trails & Recreation Area. The cost of the e-bikes would be covered by the grant and the city would need to pay to maintain the e-bikes and station. Murtha, Craney and Gottsch noted that they attended an e-bike demonstration with Foundation Members and a Heartland B-Cycle rep. Murtha reported that the e-bikes have a nice set up, you can ride the e-bike for one hour but then you must check it back in to a charging station to avoid being charged a \$5/hour fee. Murtha noted that the e-bikes weigh about fifty pounds each so it could limit who could use them. Murtha thinks the e-bikes are a great opportunity but due to lack of connecting trails feels we should hold off on this project for right now. Craney said the e-bikes are wonderful and easy to ride especially up hills; however, there are no connecting trails to go other places other than riding down to Heron Bay. Since there is no charging station at Heron Bay, riders would be charged extra if they stayed to enjoy the establishment. If riders wanted to head north to Prairie Queen or Chalco, they would be required to ride on Hwy 50 or 132<sup>nd</sup> Street. Craney really likes the e-bikes but does not feel our community is ready for them without better connection points and does not feel they would get much use. Neitzel thinks the e-bikes are nice but feels the novelty of the e-bike would wear off quickly and with how heavy the e-bikes are felt it would restrict families with children as they would be excluded from safely riding them due to the weight of the e-bike. Council agreed that the opportunity is nice but does not feel Springfield has a high demand for an e-bike station at this point. Osborn felt that if we got e-bikes perhaps other communities would follow. Hentzen reported that the Springfield Community Foundation Board plans to keep on looking for

more ideas for our community, as they are all about improving the community. No action taken on agenda item 3.

Motion by Herzog, seconded by Neitzel, to move agenda item 11, regarding infield work on the baseball field at Buffalo Park, after agenda item 3. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 11.** Jason Jones with Springfield Legion Baseball Association requested the city provide a financial contribution towards infield work that is needed at the Buffalo Park baseball field. Jones reported that the infield is in dire straight with a significant dip and valley going to first base. Jones said they will need to have all the infield sod removed, the land regraded and leveled, and irrigation redone. New sod will then need to be laid and watering done often prior to the water being shut off for the season. Jones noted that Mack Bros. could complete the work in seven to ten days. Springfield Platteview Schools has agreed to pay one-third of the cost of the project if the city can pay one-third as well. Motion by Neitzel, seconded by Herzog, to approve the bid from Mack Bros. in the amount of \$16,990.00 contingent upon Springfield Platteview Schools and Legion Baseball each paying one-third of the project cost. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 4.** Motion by Herzog, seconded by Neitzel, to exceed the budget lid limit by an additional 1% for the fiscal year 2023-2024. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 5.** Council Member Murtha introduced the following resolution and moved its adoption. Council Member Herzog seconded the motion for the adoption of the resolution and on roll call the following Council Members voted in favor of said motion: Neitzel, Herzog, Murtha, Craney. ## RESOLUTION 2023-20

### FINAL TAX LEVY

**WHEREAS**, Nebraska Revised Statutes 77-1632 and 77-1633 provide that the property tax request for the prior year shall be the property tax request for the current year for the purposes of the levy set by the County Board of Equalization, unless the Governing Body of the City of Springfield passes by majority vote a resolution or ordinance setting the tax request at a different amount; and

**WHEREAS**, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

**WHEREAS**, it is in the best interest of the City of Springfield that the property tax request for the current year be a different amount than the property tax request for the prior year; therefore, the Springfield City Council requests the new property tax rate be changed from the levy rate of the prior year to the levy rate for the General Fund of 0.475924 and the Bond Fund of 0.063211 for a total levy rate of 0.539135 for Fiscal Year 2023-2024.

# NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SPRINGFIELD, SARPY COUNTY, STATE OF NEBRASKA, THAT:

1. The 2023-2024 property tax request be set at \$1,141,518.30 for the General Fund and

\$151,615.00 for the Bond Fund, for a total of \$1,293,133.30.

- 2. The total assessed value of property differs from last year's total assessed value by 44% (total assessed value in 2022-2023 of \$166,314,375 and total assessed value in 2023-2024 of \$239,853,171.).
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$0.438309 per \$100 of assessed value.
- 4. The City of Springfield's property tax rate for last fiscal year 2022-2023 was \$0.632115 per \$100 of assessed value.
- 5. The City of Springfield proposes to adopt a property tax request that will cause its tax rate to be \$0.539135 per \$100 of assessed value (General Fund of 0.475924 and Bond Fund of 0.063211) for Fiscal Year 2023-2024.
- 6. Based on the proposed property tax request and changes in other revenue, the total operating budget of the City of Springfield will be less than last year's by -15%.
- 7. The vote on this resolution shall be recorded on this resolution.
- 8. A copy of this resolution be certified and forwarded to the Sarpy County Clerk and filed with the Auditor of Public Accounts in accordance with applicable law.
