Regular Agenda

Agenda Item 1. Sgt. Kyle Percifield reviewed the Sarpy County Monthly Service Report. He stated that parking tickets have slowed down this past month. Sgt. Percifield reported there was an incident at the group home that resulted in an arrest. He also stated that the Sarpy County Fair was calm this year.

Agenda Item 2. Motion by Herzog, seconded by Neitzel, to authorize the Adair Family to purchase a plaque and bench to match those on Main Street to be placed on the front sidewalk at 205 Main Street in honor of their parents, Glenn and Ginny Adair. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 3. Mayor Roseland reviewed the staff report stating that Jeff Ray, our current city planner, is leaving JEO Consulting Group to start his own consulting firm. Mayor Roseland stated that Ray has assisted the city for many years, on many projects. Mayor Roseland questioned if there was a noncompete clause to take into consideration. Barb Henninger, City Clerk, stated that JEO is aware of Ray's plans and has an agreement with him to leave JEO with four of his clients, the city being one of them. Bill Seidler, City Attorney, noted that the agenda stated a 30-day termination notice to JEO Consulting Group while the staff report says it is only a 7-day termination notice. Upon further investigation of the JEO Consulting Group contract, the notice of termination only required a 7-day notice. Motion by Neitzel, seconded by Herzog, to approve the 7-day termination notice to JEO Consulting Group for zoning and planning administration services. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 4. Council Member Murtha introduced Resolution 2025-16 and moved its adoption. Council Member Neitzel seconded the forgoing motion and on roll call on the passage and adoption of said resolution, the following voted AYE: Neitzel, Herzog, Murtha. The following voted NAY: None. The following were absent: Craney. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows.

RESOLUTION 2025-16

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, and Ray Planning Solutions, LLC, (RPS) wish to enter into an Agreement for Planning Services for the purpose of RPS providing zoning and planning administration services; and

WHEREAS, RPS will assist and work under the direction of the City Administrator; and

WHEREAS, anticipated service includes but is not limited to assistance with Planning Commission (PC) and Board of Adjustment (BoA) meetings: conducting tasks that support the PC, advising the PC/BoA on matters before the bodies, processing of zoning permits applications, and investigating and reporting on zoning violations; and

WHEREAS, RPS will consult with the City Administrator on planning projects as needed; and

WHEREAS, RPS will review planning and zoning applications and conduct site inspections as needed; and

WHEREAS, RPS will work with city staff to advertise and conduct public hearings and meetings as needed for planning and zoning issues with PC and the City Council; and

WHEREAS, City will compensate RPS at an hourly rate of \$200 per hour for the year 2025, which includes mileage, phone calls, meals and travel expenses; and

WHEREAS, planning projects with an estimated fee to exceed \$2,500 shall be submitted to the City Council for task approval under the Master Service Agreement; and

WHEREAS, this agreement shall be reviewed and renewed annually, with potential adjustments to the hourly rate; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to enter into the Agreement for Planning Services attached hereto as Exhibit "A."

Department Reports

Agenda Item 1. Neitzel reported that Heath Shemek, Water/Sewer Operator, has been flushing hydrants. The south side of town is complete; he is currently working in Highview. The event was managed well. Tyler Holdorf, Parks Director, has been watering trees.
