A regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. at City Hall on Tuesday, February 15, 2022. Present were Mayor Bob Roseland; Council Members: Mike Neitzel, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. RESOLUTION APPROVING AN AGREEMENT TO TRANSFER PROPERTY LEGALLY DESCRIBED AS LOT 7A1, GRAND SQUARE ADDITION TO THE SARPY COUNTY AGRICULTURAL SOCIETY, INC.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, IN THE STATE OF NEBRASKA:

WHEREAS, the City of Springfield offers to transfer to the Sarpy County Agricultural Society, Inc. property legally described as Lot 7A1, Grand Square Addition, an addition to the City of Springfield, as surveyed, platted and recorded in Sarpy County, Nebraska; and

WHEREAS, in connection with a real estate exchange signed May 20, 2008, by the City of Springfield and June 10, 2008, between the City of Springfield and the Sarpy County Agricultural Society, Inc., the Sarpy County Agricultural Society believed it was the owner of the property described; and

WHEREAS, the City of Springfield and Sarpy County Agricultural Society want to resolve issues regarding ownership, maintenance and use of the property described; and

WHEREAS, an Agreement to Transfer Property shall outline the terms and conditions of the property transfer.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, NEBRASKA, that the Agreement to Transfer Property, a copy of which is hereby attached as Exhibit "A," is hereby approved.

RESOLUTION OF THE CITY COUNCIL OF SPRINGFIELD, NEBRASKA
AUTHORIZING SALE OF CITY PROPERTY AND DIRECTING PUBLICATION OF NOTICE

RECITALS

The City Council of the City of Springfield, Nebraska deems it advisable and to be in the best interests of the inhabitants of the City to sell the following described real property, belonging to the City of Springfield, Nebraska and situated in Sarpy County, Nebraska:

Lot 7A1, Grand Square Addition, an Addition to the City of Springfield, as surveyed, platted and recorded in Sarpy County, Nebraska; formerly known as Tax Lot 7A1, Section 24, Township 13 North, Range 11 East of the 6th P.M.,

and which is not deemed necessary, presently or in the foreseeable future, for public use by the City of Springfield, Nebraska.

The Sarpy County Agricultural Society, Inc., a Nebraska Public Agency, has offered to acquire said real property for valuable consideration and therefore the requirement of Nebraska Revised Statute §17-503 to sell said real property at public auction or by sealed bid is inapplicable. The terms of the offer to purchase shall be contained in a document titled "Agreement to Transfer Property" between the City of Springfield, Nebraska and the Sarpy County Agricultural Society, Inc., a copy of which will be kept on file in the office of the City Clerk of Springfield, Nebraska.

NOW, THEREFORE, the City Council of the City of Springfield, Nebraska does resolve as follows:

SECTION ONE PUBLICATION

The City Clerk shall publish notice of the proposed sale of the above-described real estate once each week for three consecutive weeks in a legal newspaper published in or of general circulation in the City of Springfield, Nebraska.

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield reserves the right to establish and update personnel policies and procedures which are within their legal authority; and

WHEREAS, the Springfield City Council desires to update the rate of compensation for the Mayor and City Council Members; and

WHEREAS, the Mayor whose term of office begins at the first regularly scheduled meeting in December of 2022 shall receive a rate of compensation at \$600.00/month (\$7,200.00/year); and

WHEREAS, City Council Members whose term of office begins at the first regularly scheduled meeting in December of 2022 shall receive a rate of compensation at \$400.00/month (\$4,800.00/year); and

WHEREAS, City Council Members whose term of office begins at the first regularly scheduled meeting in December of 2024 shall receive a rate of compensation at \$400.00/month (\$4,800.00/year); and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the new rates of compensation for the Mayor and City Council Members are hereby approved.
