MINUTES

A regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. at City Hall on Tuesday, July 20, 2021. Present were Mayor Bob Roseland; Council Members: Mike Neitzel, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

Consent Agenda

Motion by Herzog, seconded by Craney, to approve the Consent Agenda. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Regular Agenda

Agenda Item 1. Omar Ruiz with Turner Construction was present on behalf of Bob Campos. He said they are requesting this waiver in order to prep the pad for the building. The preparation is a very dusty operation, so they want to do it overnight for public safety reasons. The work will take approximately five days and be done Monday through Friday. Ruiz noted that they are tentatively planning to do the work August 9-13; however, it will be weather dependent. Motion by Murtha, seconded by Neitzel, to waive Springfield Municipal Code §6-333 Misdemeanors; Loud, Unnecessary Noises, Subsection H Construction or Repairing of Buildings to allow overnight construction work at 14671 Capehart Road (Lot 1, Gemini), for the whole month of August to allow Turner Construction time to complete prep work for the building pad. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 2. Jake Kinman with the Sarpy County Agricultural Society requested permission to use golf carts / gators for fair activities. Unfortunately, UTVs are not available to rent this year due to supply and demand, so the group can only rent golf carts. Herzog expressed concern with driver restrictions and recommended that only licensed drivers be permitted to operate the golf carts. Motion by Herzog, seconded by Murtha, to allow the Sarpy County Agricultural Society to operate golf carts for fair activities during the Sarpy County Fair to be held August 4-8, 2021, with the stipulation that only licensed drivers at least 16 years of age or older may operate said golf carts. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.
