Agenda Item 1 & 2. Samantha Hurst, 900 N. 4<sup>th</sup> Street, Hailie Shadle, 865 6<sup>th</sup> Avenue, and Payton Mackstaller, 865 5th Avenue, discussed their concerns for people speeding on 5th Avenue at approximately forty miles per hour. Hurst asked if a speed bump could be installed or if a portable radar sign could be put up to slow speeders down. Murtha asked Hurst, Shadle and Mackstaller if they noticed if the speeders are younger aged or middle aged. Shadle reported that the speeders are younger age people. Neitzel asked if there is a worse time of day for speeders. Shadle reported that mid-day and afternoon are the worst times. Craney noted that there are pros and cons to the girls' request. Yes, it slows some people down, but speed bumps are hard to maintain as the street must have a big chunk cut out of it, then filled in at just the right grade, and then painted regularly to keep up visibility. Craney mentioned that he has been through Hawaiian Village recently and they have gradual speed bumps that he found to not be irritating. Murtha asked Hurst, Shadle, and Mackstaller what problems they could see us having with speed bumps. Shadle reported that kids might play on the speed bumps. Neitzel inquired if the city could obtain data as to how fast people are going in that area. Kathleen Gottsch, City Administrator, reported that the problem is all over town, and many residents want speed bumps. Jason Sequenzia, 850 N. 2<sup>nd</sup> Street, requested a speed bump be installed on North 2<sup>nd</sup> Street. He said if a speed bump could not be installed then he requested the installation of a stop sign at the intersection of 2<sup>nd</sup> Street and 1<sup>st</sup> Street. Brad Reinhard, 805 N. 2<sup>nd</sup> Avenue, commented that at least a speed bump would slow people down. Herzog questioned if the younger drivers would try to possibly jump the speed bumps versus slowing down. Sequenzia noted that he recently bought a slowdown sign, and someone actually ran over it. Mayor Roseland expressed interest in requesting the city engineer with Olsson to do a traffic study as well as install more speed radar signs. Council also requested that speeding issues be addressed in the next community newsletter as well as through city social media. They requested the Sarpy County Sheriff's Department have more of a presence in town and watch for speeders.

# RESOLUTION 2023-13

#### **RESOLUTION ADOPTING A SAFETY MANUAL**

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska, as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, wishes to adopt a Safety Manual to create a safe, secure, and healthy work environment; and

WHEREAS, it is the City of Springfield's objective to provide training, policies, procedures, and professional consultation that will reduce the number of injuries in the workplace to an absolute minimum; and

WHEREAS, through the Safety Policy the City of Springfield shall create a safety committee to assist in making recommendations and addressing safety and health concerns within the workplace.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, by a majority vote resolved that the Safety Policy for the City of Springfield, a copy of which is attached hereto as Exhibit "A", shall become effective immediately upon approval, and will remain in effect until further notice of amendment or revocation.

Fireworks were cancelled for Springfield Days due to the weather forecast and lightning. She inquired if Council wanted to do the fireworks another time. Murtha recommended we do them during the holiday tree lighting. Staff will check into that option. Gottsch also reported that a burn permit was obtained last week so the maintenance department burned down the tree pile. Council agreed to reopen the gate for residents to dump tree debris.
