A. Kathleen Gottsch, City Administrator, reviewed the existing policy which was adopted and became a part of our plan in 2022. The Sarpy County and Cities Wastewater Agency felt there were enough changes to warrant updates to the Growth Management Plan Policies and Procedures (GMP Policies). An exception would be to add language to septic systems to replace or reconstruct existing property with no additional fees being charged.

Webster inquired if these changes would be consistent with the other agency cities. Gottsch stated all member cities of the Sarpy County Wastewater Agency would adopt the same policies.
