PLANNING COMMISSION MINUTES July 14, 2020

- 1. Meeting called to order at 7:00 p.m.
- 2. Present: Jerry Webster, Kyle Fisher, Elizabeth Chartier, Dave Kulm. Absent: Jim Opitz, Sue Peplow.
- 3. Motion by Fisher, 2nd by Chartier to approve meeting agenda. Ayes: Webster, Fisher, Chartier, Kulm. Nays: None. Motion carried.

4. Chartier noted Item 6A did not have roll call documented. Motion by Fisher, 2nd by Webster to approve the June 9, 2020 Planning Commission meeting minutes with a correction to add roll call to Item 6A. Ayes: Webster, Fisher, Chartier. Nays: None. Abstain: Kulm. Motion carried.

5. Public Hearings

A. Motion by Fisher, 2nd by Kulm to open a public hearing to consider the final plat application filed by DAMMM Land, LLC, applicant, and RTR Development, LLC, owner, on property legally described as the North ½ of the Northeast ¼ of Section 23, Township 13 North, Range 11 East of the 6th P.M., Sarpy County, Nebraska; and generally located on the southwest corner of Hwy 50 and Platteview Road (Lots 1-4 and Outlots A & B, Springfield Commerce). Ayes: All. Nays: None. Motion carried. Public hearing opened at 7:02 p.m.

Doug Kellner, applicant's engineer with TD2 Engineering & Surveying, 10836 Old Mill Road, reviewed the final plat application for Phase 1. He noted that access concerns by the city would be resolved by the applicant and property owner.

Kathleen Gottsch, City Administrator, stated the city engineer recommended turn lanes be added at Park Drive onto Hwy 50. Gottsch further noted city staff is comfortable with proceeding provided the required revisions are made prior to City Council approval.

Chartier inquired if an environmental study had been completed on the property. Kellner said the applicant did not complete an environmental study. Gottsch inquired if the owner, Randy Sump, had provided an environmental study. Kellner said that Sump had done a study.

Gottsch noted that Jeff Ray, City Planner with JEO Consulting Group, reviewed the final plat and recommended approval contingent upon outstanding issues being addressed.

No further questions or comments were made.

Motion by Fisher, 2nd by Chartier to close the public hearing. Ayes: All. Nays: None. Motion carried. Public hearing closed at 7:05 p.m.

Gottsch said that Ray suggested the Planning Commission recommend the City Council grant a 60-day moratorium on acting upon applications for any permits, zoning changes or zoning approvals for any proposed power generation, alternative energy production facilities, solar energy systems, utilities and associated facilities. The moratorium would allow adequate time to work with the Planning Commission and City Council to make said amendments.

Michaela Valentin, Government & Community Relations Manager with OPPD, said she looks forward to working with the city on the text amendments and offered Planning Commission Members to participate in a presentation to learn about OPPD's Power with Purpose project.

No further questions or comments were made.
