- 1. Meeting called to order at 7:00 p.m.
- 2. Present: Jerry Webster, Elizabeth Chartier, Kyle Fisher, Joe Parr, Jim Opitz, Sue Peplow. Absent: David Kulm was absent from the entire meeting. Jim Opitz and Sue Peplow arrived at 7:04 p.m.
- 3. Motion by Fisher, 2nd by Parr to approve meeting agenda. Ayes: Webster, Chartier, Fisher, Parr. Nays: None. Absent: Opitz, Peplow, Kulm. Motion carried.
- 4. Motion by Parr, 2nd by Fisher to approve April 14, 2020 Planning Commission meeting minutes. Ayes: Webster, Chartier, Fisher, Parr. Nays: None. Absent: Opitz, Peplow, Kulm. Motion carried.
- 5. Public Hearings
 - A. Motion by Parr, 2nd by Fisher to open a public hearing to consider a conditional use permit renewal application submitted by Cwach Automotive Inc., applicant, and Williams Enterprises LLC, owner, for an outdoor storage container located at Lot 2, Neitzels Corner, City of Springfield, Nebraska, generally located at 15775 South Hwy 50, and zoned Business Highway and within the Highway Corridor Overlay District. Kathleen Gottsch, City Administrator, reviewed the application. Photos of the entire property were included with the application for review. Jeff Ray, City Planner with JEO Consulting Group, found the renewal acceptable. Ray was also in favor of extending the renewal agreement from an annual renewal to a two or three renewal.

Chartier inquired if there had been any break-ins to the storage container. Staff noted that they were not aware of any issues. City staff would like to see the property continue to be improved and signs placed on the building identifying the company.
