## PLANNING COMMISSION MINUTES March 11, 2025

- 1. Meeting called to order at 7:02 p.m.

- 3. Motion by Fisher, 2<sup>nd</sup> by Webster to approve the meeting agenda. Ayes: Kulm, Opitz, Chartier, Webster, Fisher. Nays: None. Motion carried.
- 4. Motion by Fisher, 2<sup>nd</sup> by Opitz to approve minutes of the January 14, 2025, Planning Commission Meeting. Ayes: Kulm, Opitz, Chartier, Webster, Fisher. Nays: None. Motion carried.

- 6. Public Hearings
  - A. Motion by Webster, 2<sup>nd</sup> by Opitz to open a public hearing to consider applications submitted by the City of Springfield for zoning text amendments and for an application for a conditional use permit filed by Dr. Micah Kohls / Woodland Animal Hospital to operate a Small Animal Veterinary Service on property zoned Downtown Commercial and legally described as Lot 11, Block 12, Springfield, NE, and generally located at 105 Main Street, Springfield, NE. Ayes: Kulm, Opitz, Chartier, Webster, Fisher. Nays: None. Motion carried. Public hearing opened at 7:04 p.m.

Kulm read each item and opened the floor for discussion and questions.

Opitz questioned the grooming aspect being removed from the text amendment 6B & 7B. Andie Ledenbach, Planning Commission Clerk, explained this portion of the text amendment strictly addresses kennels and boarding.

Opitz further questioned the size of the building being able to accommodate a veterinary clinic. Ledenbach commented a building permit application would be submitted for all construction and would be required to meet all standards and guidelines.

Opitz questioned if there would be enough parking to accommodate the veterinary clinic. Ledenbach referenced the buildings' previous uses with similar public parking needs. Ledenbach commented that there is additional parking in close proximity to the clinic.

Opitz inquired if this location was in the Highway Corridor Overlay District. Ledenbach commented it is not in the Overlay District. It is zoned Downtown Commercial District.

Webster inquired if Kohls would be able to operate without a Conditional Use Permit. Ledenbach said this type of use requires a Conditional Use Permit.

Webster asked where dogs would be kept after surgery. Ledenbach stated there would likely be kennels for dogs to recover after surgery. No overnight boarding will be done.

Webster asked if grass would be installed for dogs to relieve themselves. Ledenbach stated there was no grass currently and it would not be allowed in the front of the building.

No further questions or comments were made.
