Planning Commission Minutes May 10, 2022

Motion by Skorcz, 2nd by Webster to open a public hearing to discuss an application filed by Laura and Justin Huscroft, property owners and subdividers, for a replat of Lot 5, Prairie Toehold, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska, and generally located at 13248 Birchwood Plaza, Springfield, Nebraska. Kathleen Gottsch, City Administrator, reviewed the replat application. Prairie Toehold is an 8-lot acreage subdivision zoned Agriculture Residential (minimum of 5+ acres) located north of Fairview Road and west of 132nd Street. The Huscrofts wish to construct an accessory structure on the south side of their property. There is currently a 60' wide access easement on the south side of their property that was created as part of the original platting for the subdivision. According to city zoning regulations, accessory structure setbacks in the Agriculture Residential District are from either the property line or access easement, whichever is stricter; therefore, the accessory structure needs to be 130' from their property line. Huscrofts are asking that the access easement be decreased from 60' to 30'.

Gottsch noted that the original subdivision agreement and covenants will need to be amended to address the change in size of the access easement. An easement release may also need to be filed against the property, per the Sarpy County Surveyor.

Laura Huscroft expressed gratitude to the Planning Commissions their support.
