Kathleen Gottsch, Springfield City Administrator, reviewed the intention of the applicants request to replat and subdivide lot 3 in to 3 separate lots extending Rotina Drive into a circle. She further stated the entrances will have a shared parking lot that will be reviewed once the permit is submitted. Gottsch further noted the replat is a simple subdivision replat that is required to go through the process for City Council approval. Opitz inquired if this would necessitate a zone change. Gottsch commented the use is the same allowing one large lot be split into 3 smaller lots.

Gottsch noted the applicant was in the process of providing additional information regarding legal description details, drawings and various items needing language updates.

Fisher inquired who would be responsible for street services. Gottsch informed the commission Sarpy County would be responsible for all street services and all codes have been met.
